QUARTERLY ACTIVITIES REPORT – 3 MONTHS ENDED 30 JUNE 2021

Ikwezi Mining Limited (ASX: IKW, Ikwezi Mining or Company).

Operational update

The mining production was lower than expected during the current quarter. This was mainly due to the abrupt stoppage of mining services by the mining services provider's sub-contractor, which led to the temporary cessation of the mining operations while the tendering process was ongoing for the substitute mining services provider, for the continuation of mining operations. Despite the little hiccup in the rendering of the mining services during the current quarter, the site establishment with the substitute mining services contractor was started and completed during the quarter.

Steady progress is being achieved with the Emoyeni wash plant operations with a total feed of 135,905 tonnes for the 3 months and a record production of 58,429 tonnes for the month of June 2021.

Finance update

Cash and cash equivalents of the Company as at 30 June 2021 totalled A\$0.214 million (31 March 2021: A\$ 1.523 million), together with undrawn finance facilities in the amount of A\$0.732 million.

No expenditure was incurred on exploration or development activities during the quarter. The expenditure of A \$4.7 million was incurred on mining production activities during the quarter.

Thermal coal markets

Thermal coal prices (API4 Richards Bay - FOB Richards Bay for 6,000 kcal, NAR product) gradually increased during the current quarter. Prices have further strengthened after the quarter. The API4 forward curve is currently trading at approximately over USD120 per ton for July 2021 and predicts an average selling price of USD 115 for the next 12 months.

Future Developments

The Company, through its Emoyeni wash plant aims to ramp up its throughput to achieve 75 000 tonnes on a monthly basis in the coming quarter. Further, continuation of activities and obtaining of regulatory approval processes to bring new pits into production is set to take place in the coming quarter.

Summary

Key management focus in the short term remains on improving the product value through beneficiation of the coal at the Emoyeni wash plant.

Zarbon Coal (Pty) Ltd or Zarbon, a related party, provided a letter of comfort to Ikwezi to provide it with a finance facility of up to USD4.3 million (approximately AUD6 million). Any amounts advanced under the facility will attract interest at an annualised rate of 5% p.a. Any amounts drawn down under the facility need to be repaid, together with any interest due, on or before 31 December 2021.

Answer: No, during the current quarter no sales were realised. Sales are expected to be realised during the coming quarters which will improve the operating cashflows.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes, coal stockpiles have been accumulated and these will result in sales which will significantly improve cashflows, furthermore the finance facility is still in place. A sales contract to the value of approximately AUD 6,7 million has been concluded to date.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, as set above, the Company expects to be able to continue its operations and meet its business objectives. The operational plan over the next few months will continue being focussed on increasing sales thereby maximising cash flow and improving productivity.
